The Burns Town Council met in regular session on April 23, 2018. Members present were Mayor Ralph Bartels, Council Members Rocky Stoner, Dennis Bastian, and Judy Johnstone. Council Member Betty Nussbaum was absent from this meeting. Also present was Town Clerk Toni McNamar, Town Maintenance Darius Mandel, and Glen Crumpton from Laramie County Communications Center.
