

Burns Town Council Meeting
August 27, 2018

The Burns Town Council met in regular session on August 27, 2018. Members present were Mayor Ralph Bartels, Council Members Rocky Stoner, Judy Johnstone, Betty Nussbaum, and Dennis Bastian. Also present was Town Clerk Toni McNamar and John Abrams with Laramie County School District #2...

At 1:00 pm Mayor Bartels called the meeting to order and the Pledge of Allegiance was performed. Those present were informed the meeting was being recorded.

John Abrams with Laramie County School District #2 was present to discuss terms of lease of the north gym and the wrestling area. Mr. Abrams reported that the more he reviews the lease the less he has to say. He would like a reasonable rate to be able to store the mats in the wrestling area in the off season. He reported that there may come a time that they will not need the wrestling area, as the school may be considering building a wrestling area at the high school

Mr. Abrams is a little concerned about having to pay all of the utilities in the north building. Judy Johnstone explained to him that it started because of the fact that there is only two other tenants in the building and the coaches tend to leave the doors propped open during practices and they turn the heat in the wrestling room up to 85 degrees. Mr. Abrams reported that he is very happy working with Toni during the leave times.

Mayor Bartels brought up a concern he had regarding the fact that he feels the people at the school do not treat the ambulance supervisor very well. Jeff has asked for a schedule so that they ambulance can do standby at the football games and has not received one. The ambulance is provided free of charge for these events... Mr. Abrams will check into these concerns.
